How the Constortium Works

"Registering association" refers to the association that is submitting the list of registrants to the LSO. They will pay the total to the LSO and will send your association an invoice for its portion (i.e. **cost per registrant from column D plus HST**). Each "home" association can decide whether they would like to charge their members an administrative fee, which the home association retains. Please remit payment to the registering association as soon as possible. Payments must be received before year end at the latest. Payments must be made from the "home" association to the "registering" association. The "registering" association will not accept individual payments directly from "home" association members. If "home" associations do not wish to collect payment from their members to submit to the "registering" association, then the "home" associations should direct their members to register directly with the "registering" association through whichever means (online or email) the "registering" association uses to collect registration.

Only **live programs** will be offered for OCLA group registration. No replays, e-courses, or on-demand courses will be coordinated in this sheet. Refer to the [Overview](#) tab for the list of programs.


Do not email the registering association your list of registrants. **You must list your registrants in the appropriate program tab in order for them to be registered.** In this way, everyone will have access to the list of registrants should last-minute issues arise with the registering association (e.g., illness). The event tab is listed in Column G of the [Overview](#) tab.

You must have your registrants in the event tab **7 days before the program date** to be included in the group registration. If you are unsure about this deadline, please see Column F in the [Overview](#) tab.

The LSO requires **11 or more registrants for the 50% discount** to apply. If fewer than 11 registrants have signed up for the program, the group registration submission will be cancelled. **The registering association must let the participating associations know if a group registration is cancelled and it must be marked on the event tab. The home association is responsible for letting their members know the group submission is cancelled.** Your members can still register themselves with the LSO up until the day of the event, however, not at the discounted group rate.
