## Judicial Management of All Judicial Proceedings not Governed by Rule 77 (Province-wide)

This practice direction advises the profession how all civil proceedings in Ontario, not subject to case management under Rule 77, may be judicially managed under the *Rules of Civil Procedure*.

Motions to Transfer a Civil Proceeding in the Central East, Central West, Central South and Toronto regions under Rule 13.1.02 of the *Rules of Civil Procedure* (Regional)

This practice direction governs motions to transfer civil proceedings in the Central East, Central West, Central South and Toronto regions.

#### National Database of Class Proceedings (Province-wide)

This practice direction advises the profession of class proceedings procedures.

#### Proceedings Under the Class Proceedings Act, 1992 (Province-wide)

This practice direction provides scheduling information regarding class proceedings in each region according to the Class Proceedings Act, 1992.

#### Trial Dates in the Superior Court of Justice and in the Ontario Court of Justice (Province-wide)

This practice direction is intended to ensure that trials, hearings, and appeals are scheduled in the chronological order lawyers make their commitments to appear in court.

Form 14B Motions are only applicable in the following locations in the Central South region: Brantford, Cayuga, Kitchener, Simcoe, Welland.
