Subject: Provincial Land Transfer Tax Changes

Provincial Land Transfer Tax (PLTT) changes

Important Provincial Land Transfer Tax (PLTT) changes are being introduced that affect Transfer Type Instruments. These changes involve the collection and submission of additional information about applicable conveyances in advance of the Instrument being signed in Teraview. The information will be captured by submitting a form outside of the Teraview system.

The changes are being introduced in two phases:

Phase 1 April 24th – Both the Prescribed Information for Purposes of Section 5.0.1 Form and the new PLTT statements located in the explanations tab will be available for completion. Beginning on April 24, 2017 the submission of the form will be mandatory. The Ministry of Finance will provide a transition period from April 24 to May 5, 2017, where any deficiencies relating to the form will not incur penalties.

Phase 2 May 8th – The selection of the new PLTT statements located in the explanations tab will be mandatory and will be enforced at the time of signing and registration of an Instrument.

What do I do with the Confirmation Number?


Once the form has been submitted, you will receive a Confirmation Number that needs to be inputted into Teraview. For more information, please see the Ministry of Finance [bulletin](#).

Teranet Express has added a self-serve option so end users can find the Confirmation Number for a form they have submitted.


To access this self-serve option:

You will have to submit the form again. Please note that you will receive a new Confirmation Number that you will have to input in Teraview.

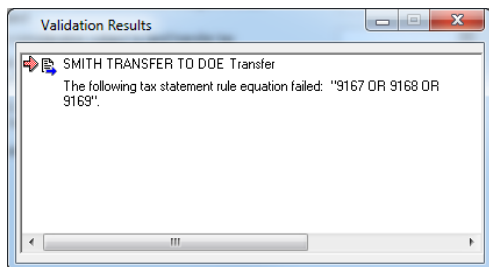
I didn't save/print a copy of the PDF form?

What will happen to my Instruments as of May 8, 2017?

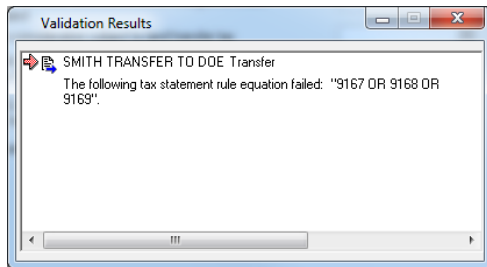
WIP Instruments as of May 8, 2017:

If statement 9167 or 9168 or 9169 has not been selected at the time of signing you will receive the following error: *The following tax statement rule equation failed: 9167 OR 9168 OR 9169*



Previously signed Instruments after May 8, 2017

If the instrument is not re-signed the following error will occur at registration: *The following tax statement rule equation failed: 9167 OR 9168 OR 9169*



What happens to Instruments Registered prior to May 8th, 2017?

These instrument types will not be impacted since the mandatory rule was introduced after the Instruments were registered.
