Beginning on Monday June 23rd, 2025, defence counsel, duty counsel and self-represented defendants wishing to schedule a Crown Pre-Trial (CPT) with the Brantford Crown Attorney's Office, will be able to do so electronically through the following portal:

Since 2021, the Brantford Crown Attorney's Office scheduled CPTs using an application called "Appointlet". The Brantford Crown Attorney's Office will now schedule CPTs using an application called "MS Bookings". Any CPTs already booked using Appointlet do not need to be rescheduled. All new CPTs must be scheduled using "MS Bookings".

Counsel should continue to book according to the Case Management Team with carriage of their client's matter. If you are uncertain which Case Management Team has carriage of the matter, please contact our office via email at VirtualCrownBrantford@ontario.ca, or by phone at (519) 758-3480 to confirm. Using the scheduling tool, counsel will be able to book a 30-minute CPT without needing to first coordinate schedules with the assigned Crown.

Once booked, counsel will receive a confirmation email and can add the appointment to

their calendar if they wish to do so. At the scheduled time, a Case Management Crown will

call counsel at the number provided when booking the appointment.
